Electricity and gas information

- 1. For the established large sites, the Electricity and Gas supply for the Trusts are under contract with Crown Commercial Services (CCS) with the exception of a number of new and small building assets as detailed below. The buildings assets supplied under the CCS framework agreement includes: Kidderminster Hospital; Alexandra Hospital; Worcester Royal Hospital (PFI) and Newtown Road Retained Estates. EDF Energy and Corona Gas are the electricity and gas suppliers under the CCS framework agreement. The current CCS framework agreement expires on 31st March 2016.
- 2. Utilities supplies to Trust buildings currently outside of the CCS Framework agreement for energy supply services includes the following assets (and the none HH site are indicated):
 - a. 220 Newtown Worcester (British Gas current Electricity and gas Supplier) Contract agreement with British gas (Non HH)

 - d. 3 Kings Court Worcester off Charles Hasting Way Worcester (GDF SUEZ Energy current electricity supplier and British Gas current gas Supplier) Contract Inherited from previous occupier
 - e. Radiotherapy Building Charles hasting Way British Gas for Gas and GDF SUEZ Energy for electricity. Electricity supply for the building currently manage by the PFI contractor details currently not available.
 - f. Mobile Mammography unit Station Approach Hereford HR1 1DN (Npower Current Electricity supplier) Historic supplier for the site (non HH)
