I refer to your email of 28 January requesting information in respect of allografts.

I can confirm in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold some information that would be useful in terms of your request.

I have listed your questions below together with our response.

- 1) The trusts spend on soft tissue allografts for the financial year 2013/14, and which suppliers were used. £22,372 + VAT Depuy Synthes
- 2) The trusts spend on DBM (Demineralised Bone Matrix) for the financial year 2013/14, and which brands were used. £68,000 + VAT Wright Medical, Johnson and Johnson.
- 3) The trusts spend on femoral heads for the financial year 2013/14, and which suppliers were used. £30,252 + VAT. NHS Supply Chain, Johnson and Johnson, NHS Blood and Transplant
- 4) The trusts spend on bone chips for the financial year 2013/14, and which brands were used. Unable to separate from allografts based upon description used, so included in the data reported in answer to question 1.
